



OFFICIAL RESULT OF REFERENDUM VOTE

RE: CUSTOM ELECTION RULES OF THE COOK'S FERRY INDIAN BAND

DATE: July 15, 2026

TO: THE VOTING MEMBERS OF COOK'S FERRY INDIAN BAND

TAKE NOTICE that a Referendum Vote of the Voters of Cook's Ferry pursuant to the Amending Formula in s. 28 – s.31 of *The Custom Election Rules of the Cook's Ferry Indian Band, 1994* (the "Amending Formula") was held on **SATURDAY, JULY 11, 2026**, to determine if the Voters of Cook's Ferry approve and assent to the proposed amendments to the Custom Election Rules of the Cook's Ferry Indian Band as presented in the June 5th, 2026 document (the "Proposed Amendments").

As outlined in sections 28-31 in *The Custom Election Rules of the Cook's Ferry Indian Band, 1994* in order to accept these Proposed Amendments to the Custom Election Rules they must be made by a resolution at a Special Meeting where they are voted on by Electors. The vote must meet the following thresholds:

1. On first vote, No amendment shall be passed unless it receives 2/3 majority approval of all the Electors of the Band.
2. On a Second Vote, should the required majority not be possible because the required number of Electors did not vote, then a vote may be held within six (6) months. At the second vote, the amendment may be approved by a 2/3 majority approval of the Electors present if at least 2/3 of the Electors are present to vote.

The following Ballot Question was asked of the Voters of Cook's Ferry by secret ballot, as set out in sections 28 to 31 of the *Custom Election Rules of the Cook's Ferry Indian Band, 1994*:



As a Voter of Cook's Ferry Indian Band, do you approve the proposed amendments to *The Custom Election Rules of the Cook's Ferry Indian Band(1994)*, in the form dated June 5, 2026?

The Referendum Vote held on July 11, 2026 had the following result:

Threshold required: 220 "Yes" Votes

NO: 14

REJECTED BALLOTS: 0

THEREFORE, pursuant to the Amending Formula outlined in section 31 of *The Custom Election Rules of the Cook's Ferry Indian Band, (1994)*("Rules") a **second Referendum Vote** will be held on **SATURDAY AUGUST 8, 2026**, to determine if the Cook's Ferry Electors approve and assent to the proposed amendments to the Rules as presented in the June 5th, 2026 document (the "Proposed Amendments").
