



NOTICE OF REFERENDUM VOTE #2

RE: CUSTOM ELECTION RULES OF THE COOK'S FERRY INDIAN BAND

DATE: July 15, 2026

TO: THE ELECTORS OF THE COOK'S FERRY INDIAN BAND

TAKE NOTICE that the Referendum Vote to Amend the Custom Election Rules of the Cook's Ferry Indian Band held on July 11, 2026 was successful but did not reach the required threshold in section 30 necessitating a second vote in accordance with section 31 of *The Custom Election Rules of the Cook's Ferry Indian Band (1994)*; and

THAT a **second Referendum Vote** has been called pursuant to the Amending Formula outlined in section 31 of *The Custom Election Rules of the Cook's Ferry Indian Band, (1994)*("Rules") that will be held on **SATURDAY AUGUST 8, 2026**, to determine if the Cook's Ferry Electors approve and assent to the proposed amendments to the Rules as presented in the June 5th, 2026 document (the "Proposed Amendments").

The following Ballot Question will be asked of the Cook's Ferry Electors by secret ballot:

As an Elector of Cook's Ferry Indian Band, do you approve the proposed amendments to *The Custom Election Rules of the Cook's Ferry Indian Band(1994)*, in the form dated June 5, 2026?

The Electors will have the opportunity to vote in the Referendum Vote, only once, through one of the voting options, as follows:
